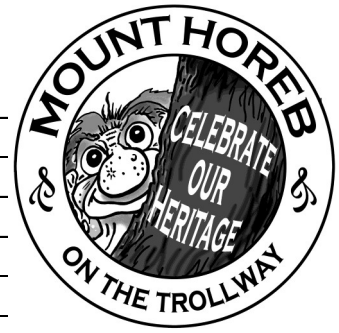

**Dues Computation:** to calculate the number of employees, divide total number of average weekly part-time employees' hours by 40 (hours of a full-time employee), add this to the number of full time employees. The total is your Full-Time Equivalency (FTE)

Membership dues for the Mount Horeb Area Chamber of Commerce are not tax deductible as charitable contributions for income tax purposes. Membership dues may be tax deductible as an ordinary and necessary business expense subject to restrictions imposed as a result of our Chambers' business advocacy.

Membership dues may be paid on a semi-annual basis, but do not qualify for the 'Early Pay' discount. First payment due January 2014, balance due July 2014. Other payments can be made by special arrangement.

At the monthly board meeting following receipt of completed application and payment, the Board of Directors will review application and determine whether the mission of the applying business is parallel to the mission of the Mount Horeb Area Chamber of Commerce.

Any individual, firm, association, corporation, partnership, entity of estate doing business in Dane or Iowa County, or located in Dane county and doing business elsewhere, interested in the commercial, industrial, agricultural, education and civic progress of this area shall be eligible for membership as a voting member. Membership dues are non-refundable.
