MOUNT HOREB AREA CHAMBER OF COMMERCE WILL:

1. Provide the vendor with a 10' x 10' to 11' x 11' space. The ground/pavement may not be level. You will be required to purchase additional booth space if you do not confine your belongings to your contracted space.
2. Electricity will be supplied but please let us know if it is needed.
3. Provide admittance for 3 people to staff vendor booth. Extra personnel will need to purchase tickets. Discount tickets may be purchased for a discount. Contact the Chamber Office for more information.

THE VENDOR WILL:

1. Provide your own equipment including tent, table, chairs, and display materials.
2. Booth will be set up at Grundahl Park by noon on the day of the event and removed from the premises by 8:00pm the same day.
3. Take all steps necessary to insure that their immediate concession area is returned to its pre-event condition.
4. Vendors must park away from the Festival Area.
5. Please be aware that the **Department of Public Health** may inspect your booth to be sure that you are meeting food health and sanitation regulations. If you have questions or concerns please contact them at **608-266-4601**.
